The **Aliphatic Solvents** and **Base Oils** in the lubricants used on the farm where incidental food contact could occur

The **White Oils, Petrolatums** and **Solvents** used in lubricants for every food contact surface in the processing plants

The same **Engine, Transmission** and **Hydraulic Oils** used in the tractor and implements used in the trucks that deliver the oranges to the processing center

The **Mineral** and **Ester-Based Refrigeration Oils** in the units keeping the juice cold





The **Solvents** used as flotation materials in the production of the paper that makes the carton

The **Paraffin Waxes** that coat the carton

The **Solvents** and **Process Oils** in the adhesives on the carton

The **Paraffinic** and **Naphthenic Process Oils** as primary or secondary plasticizers in the cap and closure

Again, the trucks, roads and refrigeration storage — getting the product to market over the road

The **Refrigeration Oils** used to keep the juice cold in the stores

The **Engine, Transmission** and **Hydraulic Oils** used on the transport of that carton to the refrigerator in your home

The **Mineral Insulating Oils** used in the transformers that keep the lights on, from start to finish, while your family goes for a glass of juice in the morning

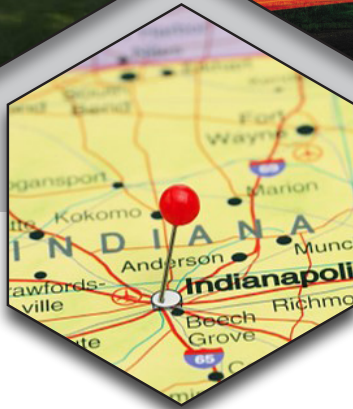
